Sir,

This has reference to NBA's letter of even number dated 13-10-2017 under which PG-Digital Communications program offered by your institution was granted provisional accreditation for 2 years upto 30-06-2019 in Tier-I by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where PG Engineering programs of an Institution were granted provisional accreditation for a period of 2 years, the period of accreditation of these programs shall be extended from 2 to 3 years subject to the condition that they meet the essential Pre-visit qualifiers. The Pre-visit qualifiers in respect of the PG-Digital Communications program submitted by Basaveshwar Engineering College, S. Nijalingappa Vidyanagar, Bagalkot-587 102, Karnataka have been considered. The PG-Digital Communications program meets all the parameters of pre-qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.


