**Subject: Extension of the Period of Accreditation granted to PG Engineering programs offered by Basaveshwar Engineering College (Autonomous) S Nijalingappa Vidyanagar, Bagalkot- 587103, Karnataka.**

Sir,

This has reference to NBA's letters of even number dated 13-10-2017, 26.02.2018 and 01-11-2018 under which following PG Engineering programs offered by your Institution was granted provisional accreditation for 3 years by National Board of Accreditation:

- (i) Computer Science and Engineering
- (ii) Machine Design

2. The National Board of Accreditation (NBA) has decided that in all cases of PG Engineering programs which were accredited for a period of 3 years up to 30-06-2020 in which the Institutions concerned have not been able to apply afresh for accreditation of the programs or if applied, the accreditation process could not be completed due to the current situation arising out of the pandemic caused by the Corona virus, the programs would be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2020 on the basis of the programs meeting the pre-qualifiers. The data submitted by **Basaveshwar Engineering College (Autonomous) S Nijalingappa Vidyanagar, Bagalkot- 587103, Karnataka** in the Pre-qualifiers has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted extension of duration of accreditation for one year. Basaveshwar Engineering College (Autonomous) S Nijalingappa Vidyanagar, Bagalkot- 587103, Karnataka is required to apply afresh for accreditation of the programs at least five months before the expiry of validity of accreditation.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Basaveshwar Engineering College (Autonomous) S Nijalingappa Vidyanagar, Bagalkot- 587103** as a whole. As such the Institution should nowhere along with its name, including on its letter head etc. write that it is accredited by NBA because NBA only accredits program(s), and not Institutions. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, as deemed necessary by the NBA. It is desired that the relevant information in respect of accredited program(s) as indicated in the Table in paragraph 2, appears on the website and information bulletin of your College/Institution.

7. The accreditation status awarded to the programs as indicated in Table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
